

Census 2001 Key Statistics:

District: Charnwood

Electoral Division: Syston Fosse

Following the recent boundary changes in Leicestershire, this area profile provides a summary of the key data for an Electoral Division using the 2001 Census.

When using this profile the following points should be noted:

- Ordnance Survey (OS) have indicated that the official release of geographical boundaries for the new electoral divisions will be autumn 2005. The data contained in this profile is derived from geographies created by LCC - based on information released by the Boundary Commission. If required the boundary information will be updated later this year.
- Furthermore, the Office of National Statistics (ONS) may decide to release Census profiles for Electoral Districts that have figures that could differ slightly from those contained in this profile. Again, if required the figures will be updated later this year.
- For disclosure reasons some of the figures have been rounded by ONS and so overall totals may be different.

Key Statistics Definitions

Amenities (1)

Occupancy rating is a census measure developed to calculate household overcrowding. It assumes that every household, including one person households, requires a minimum of two common rooms. E.g. -1 implies that there is one room too few.

Qualifications (2)

Level 3 = 2+ 'A' levels, 4+ 'AS' levels, NVQ 3 Advanced GNVQ

Level 4/5 = First degree, NVQ 4/5, HNC, HND, Qualified Teacher, Doctor, Dentist, Nurse, Midwife and Health Visitor.

Health (3)

•Limiting long-term illness covers any long-term illness, health problem or disability that limits daily activities or work.

•General Health refers to health over the 12 months prior to Census day. (29 April 2001)

•Provision of unpaid care: persons looking after, giving help or support to family members and/or neighbours because of long-term physical or mental ill-health or disability or problems relating to age.

Car / Van Ownership (4)

All cars/vans' may not be exact as households with more than 10 cars are counted as having 10 cars.

Long-term Unemployed (5)

A person is defined as being long term unemployed if the year they last worked was 1999 or earlier.

Travel to work (6)

Public transport is defined as underground, metro, light rail or tram; bus, minibus or coach (but excludes car-sharing)
